Subject: Release of balance amount of 1st installment of Central Assistance (CA) amounting of Rs. 2,31,00,000/- (Rupees Two Crore Thirty One Lakh only) (the approved CA towards Administrative & Other Expenses component of Rs. 9.23 Crore) to Govt. of Telangana under Atal Mission for Rejuvenation and Urban Transformation (AMRUT) for year 2017-18.

In continuation of sanction letter of even number dated 02.02.2018 (copy enclosed), vide which an amount of Rs. 2.31 crore was released to the State as 1st installment towards A&OE fund @ 2% annual allocation under AMRUT, I am directed to convey the sanction of the Competent Authority for the release of balance amount of 1st installment of Central Assistance (CA) @ 2% of annual allocation under AMRUT, amounting of Rs. 2,31,00,000/- (Rupees Two Crore Thirty One Lakh only) to the Government of Telangana.

2. The additional Central Assistance for A&OE under AMRUT has been considered as per the Mission Guidelines.
3. The other terms & conditions will remain same as per earlier letter dated 02.02.2018.

The expenditure involved is debitable to Major Head 3601 – Grant in Aid to State Govts, 06 - Centrally Sponsored Plan Scheme, 101- Central Assistance/Share, 24-Urban Rejuvenation Mission- 500 Habitations (AMRUT), 24.01.31-Grants-in-aid General under Grant No. 97 -Ministry of Housing & Urban Affairs for the year 2017-18 (Plan).
5. The amount of Rs. 2,31,00,000/- will be credited to the State Government's account to RBI as per procedure laid down by Ministry of Finance, Department Expenditure vide OM No. F-II (45/76/SC) dated 22.02.1977.
6. The sanction has been entered at Sl. No. 57 of the sanction register.
