OFFICE MEMORANDUM

Subject: Reform under the Atal Mission for Rejuvenation and Urban Transformation (AMRUT).

Reform implementation is one of the key elements of AMRUT and focuses on implementation of 11 Reforms. The details of these Reforms along with timeline for their implementation are given at Annexure-1 of Mission Guidelines.

- 2. Eight Reforms which have to be implemented by the States/UTs in the financial year 2015-16 are given in Table 5.1 of the Mission Guidelines. The States/UTs are required to submit the roadmap of implementation of these Reforms as part of the SAAP for 2015-16. It is prudent for States/UTs to prepare a roadmap for implementation of all 11 Reforms, also.
- 3. The AMRUT Mission incentivizes Reforms implementation by setting aside 10% funds as incentives for States/ULBs. The modalities of claiming the incentive are given in detail in para 12.3 and Annexure 2 of Mission Guidelines.
- 4. In order to claim the incentive, the States/UTs Governments are requested to prepare a road map for implementation of Reforms listed in Annexure 1 of the Mission Guidelines and also complete them in accordance with the timelines specified. Specifically, for claiming the incentive, the Reforms listed in Table 5.1(Annexure 2) would require to be completed by 31.03.2016. During April 2016, the State Mission Directors will self-assess the status of Reform implementation for the Financial Year 2015-16 and submit the self-assessment forms (Table 5.5; Annexure 2) for claiming incentive for their State. It is requested that appropriate action may be taken.
