OFFICE MEMORANDUM

Subject:

Atal Mission for Rejuvenation and Urban Transformation (AMRUT).

The undersigned is directed to say that the AMRUT was launched on 25.06.2015. The guidelines of the Mission are available on the website and copies have also been sent to the States/ULBs.

- 2. In Para 2.1 of the Guidelines it was indicated that the list of the cities/towns covered under the Mission will be notified at an appropriate time. The list of cities/towns in respect of Andman & Nicobar is in Annex-I. In Para 9.1 of the Guidelines relating to release of funds it was specified that immediately upon announcement of AMRUT, each Mission City will be given an advance of Rs.25 lakh from the State A&OE fund for preparation of SLIP/individual capacity building which will come from the ULB's share of the A&OE funds and will be adjusted in its share at the time of release of the first instalment. A sanction of Rs 0.10crore for Andman & Nicobar has been issued vide this office sanction letter No 14012/103/2015-SC-II Dated 24.07.201 and the amount will be released shortly.
- 3. In terms of para 7.2 of the guidelines States have to prepare State Annual Action Plan (SAAP) upto three times the Central Assistance (CA). The CA is to be released in three instalments of 20:40:40. The first instalment of 20% only shall be released upon approval of the SAAP during 2015-16. The SAAP may be prepared at the earliest and submitted to this Ministry for approval. A table indicating the State/UTs wise CA, the amount for which SAAP is to be prepared and the amount of first installment is on Annexe-II.
