

Subject: Release of ₹ 37,94,00,000/- (Rupees Thirty Seven Crore Ninety Four Lakh only) as Reform incentive to Govt. of Rajasthan under Atal Mission for Rejuvenation and Urban Transformation (AMRUT) for year 2017-18.

Sir,

I am directed to convey the sanction of the Competent Authority for the release of an amount of ₹ 37,94,00,000/- (Rupees Thirty Seven Crore Ninety Four Lakh only) to the Government of Rajasthan. This amount is being released as incentive for achievement of Reforms milestone mandated for financial year 2016-17 as per para 4.3 of the Guidelines of Atal Mission for Rejuvenation and Urban Transformation (AMRUT).


2. The aforesaid release will be governed in terms of the following principles/conditions.
 - i. The incentive fund is an additionally and no matching funds will be required to be given by the State/ULB.
 - ii. The State High Power Steering Committee (SHPSC) will decide the use of the incentive amount. The incentive award will only be used in Mission cities on admissible components of the AMRUT, including new projects. The SHPSC will inform the MoUD of the use of incentive funds on projects.
 - iii. The incentive cannot be used as the State share in project in the AMRUT, but can be used by the ULBs for their project funding.
 - iv. Unutilised funds for Reform incentive will be transferred to Project Fund every year.
 - v. This release will be governed in terms of provisions of GFR.
3. No Utilization Certificate is pending at this stage in respect of Reforms incentive.
4. The expenditure involved is debitable to the Major Head-3601-Grants-in-aid to State Govts.,06-Centrally Sponsored Schemes, 06.101-Central Assistance/Share, 24-Urban Rejuvenation Mission-500 Habitations (AMRUT), 24.01- Urban Rejuvenation Mission-500 Habitations (AMRUT), 24.01.31-Grants-in-aid-General under Grant no. 97 - Ministry of Urban Development of the year 2017-18 (Plan).
5. The amount of ₹ 37,94,00,000/- will be credited to the State Government's account to RBI as per procedure laid down by Ministry of Finance, Department Expenditure vide OM No. F-II (45/76/SC) dated 22.02.1977.
6. This sanction has been entered at Sl.No. 34 of the Sanctioned Register.


